Online Privacy Policy

Details outlined in this online privacy policy applies only to information collected through our website and not to information collected offline.

What information do we collect?

We collect information from you when you register or make a booking on our site or fill out a form.

When ordering or booking on our site, as appropriate, you may be asked to enter your name or e-mail address. You may, however, visit our site anonymously.

What do we use for information for?

Any of the information we collect from you may be used in one of the following ways:

How do we protect your information?

We implement a variety of security measures to maintain the safety of your personal information. Personal information that we process for any reason shall not be kept for longer than is necessary for that purpose.

- We will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information.
- We will store all the personal information you provide on our secure (password – and firewall-protected) servers.
- All electronic financial transactions entered over our website will be protected by encryption technology.
- You acknowledge that the transmission of information over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.
- You are responsible for keeping the password you use for accessing our website confidential; we will never ask you for your password (except when you log in to our website).

Any personal information we hold about you, is stored and processed under our data protection policy, in line with the Data Protection Act 1998.
